#### OLD IOTA 04 | NEW IOTA 04 | Reports

- Marcus reports from the Executive Board
  - The new contract for the International Centrum "Haus auf der Mauer" has been signed.
     We will still get money back from some contract partners, but probably not from all.
     On 10.10.2025, there will also be a meeting with Mr. Hollnack. There, the handover of personnel will be the main topic.
  - We took a closer look at the **attendance statistics** for the completed term. During this term, attendance at StuCo was slightly higher than in the previous year. Nevertheless, we are below 50 % in average attendance. We hope that this term, with many motivated people in the StuCo it will be different and we can achieve a better quota.
  - The **StET** are still ongoing. We have written a lot of contracts for the FSRs again, since they are very active and plan great events for their freshmen.
  - We received a payment reminder for €271.90 plus €2 in reminder fees and will be required to transfer this amount by October 8th 2025. Otherwise, legal action will be taken. The reason for this is, that a decision by the StuCo that students would receive money for a trip was declared invalid. Therefore, we cannot pay out the money. We are working hard to find a quick solution.
  - The Grüne Jugend has asked us, if we want to be represented with a stand at the Kraut-gassenfest or if we want to advertise the event. It will take place on 22nd October from 13:00 to 18:00. At the festival, there will be a cake buffet and various stands (NABU, ADFC, etc.). We were invited to emphasize the student concerns of a redesigned Kraut-gasse.

**Point of Order** from **Willi**: Opinion gathering: The StuCo wants to have a stand at the Krautgassenfest.

- There is currently a problem in that we are not always well-informed about the problems of the student body, as they are not brought to our attention. Students often think that they are the only ones with a problem or that nothing can be changed. Therefore, we have considered creating a new StuCo email address specifically for complaints. Then students can simply vent their frustrations, feel heard, and we learn what we need to work on.

## OLD IOTA 10 | NEW IOTA 10 | Discussion & Election: Executive Board \*\* (Election Board)

#### **Motion Text**

Dear All,

the StuCo elects a three-person executive board to lead and coordinate all of its activities. The executive board represents the student body externally and for all legal transactions and corresponding contracts at least two members of the board must sign. Additionally, the board coordinates the work of the employees, therefore fulfills the employer function of the student body, prepares, leads (or designates a leader) and follows up on sessions. They create the session materials, sends out invitations to the meetings in good time, and subsequently ensures that the records are published and the resolutions implemented. The management supports the board in these tasks. In addition, the board can decide on funding applications (term for external requests) up to an amount of €250 and releases of funds (term for internal requests) up to an amount of €500. It holds regular (usually weekly) board meetings to make these decisions and coordinate its tasks. Only those who are voting members of the StuCo can become members of the board. A majority of the votes of all StuCo members is required for election. With 37 StuCo members, this means that 19 votes are required. If the executive board does not consist of three persons for a period of two months of the lecture period, the student council must be dissolved and new elections held. The deadline for this is December 13th 2025.

Dear all,

According to §25 (1) of the constitution of the student body of the FSU Jena, the student council may set up departments to fulfill its tasks. The departments that have been set up are listed in § 16 of the order of the student council. Each department is headed by a departmental coordination team of one to three members elected by the Student Council. The departments are assigned areas of responsibility by StuCo decision. The Teacher Training Department is a so-called special department. This means that it appoints its own representatives and the Student Council no longer elects them, but only confirms them. According to § 25 (7) of the constitution, the representatives must be confirmed at the constitutive StuCo meeting. The following is a list of the departments with their areas of responsibility and representatives in the order in which they are mentioned in the order of the student council. The executive board contacted the heads of departments to ask whether they would like to be confirmed at the constitutive meeting. The representatives who did not respond are marked accordingly in the text below.

#### Description of the Departments:

#### Department for Intercultural Exchange - Int-Ro:

*Area of responsibility:* This is the point of contact for international students with questions about studying, dealing with authorities, and also non-university matters. Particular importance is attached to the integration of international students. There is close cooperation with the departments for human rights, culture, and public relations.

There is close cooperation with the Departments of Internal Affairs, Social Affairs, and Public Relations.

Area of responsibility: The task of the Teaching Department, as a special department, is to represent the academic, student department, and political interests of all teacher training students until a separate student department representation has been established. Its areas of activity include, in particular, study organization, study documents, teacher training, the Jena model, as well as changes resulting from the Bologna Process/study reform and the relevant legal basis for this course of study. In addition, it works closely with the "LehrerInnenbildungsausschuss" (Teacher Training Committee) and the "Zentrum für Lehrerbildung und Bildungsforschung" (Center for Teacher Training and Educational Research), as well as the Department for Higher Education Policy and the student department councils of the degree programs in which teacher training is offered.

#### **Public Relations Department:**

*Area of responsibility:* The Public Relations Department is the interface between the Student Council and the students and the outside world. In cooperation with trade unions and staff representatives, it strives to represent the interests of student employees at universities and to establish a collective agreement for them. The topics of studying with children, the concerns of chronically ill and differently abled students, disadvantage compensation, part-time studies, university admission, and tuition fees are dealt with in cooperation with the other departments.
